Mayor Hamm presented a proclamation declaring May 18-24, 2025 as "National Public Works Week" to Public Works Director Dennis Bothell. Mayor Hamm stated that the City is very appreciative of the work that Mr. Bothell and his staff do for the community.

CONSIDER ORDINANCE NO. 1065(25) AMENDING THE "CITY OF MOORE HOTEL/MOTEL ROOM TAX ORDINANCE" BY AMENDING SECTION 3 OF ORDINANCE NO. 378(85), PASSED AND APPROVED FEBRUARY 4, 1985, AS AMENDED BY ORDINANCE NO. 378(02), PASSED AND APPROVED SEPTEMBER 3, 2002, AS AMENDED BY ORDINANCE NO. 950(20), PASSED AND APPROVED AUGUST 3, 2020, ALSO IDENTIFIED AS PART 7, CHAPTER 5, SECTION 7-503 OF THE CODE OF THE CITY OF MOORE, OKLAHOMA, AS AMENDED, BY INCREASING THE HOTEL/MOTEL TAX FROM FIVE PERCENT (5%) TO EIGHT PERCENT (8%); PROVIDING FOR USE OF FUNDS; PROVIDING SEVERABILITY OF PROVISIONS; REQUIRING APPROVAL OF THE ORDINANCE BY A MAJORITY OF REGISTERED VOTERS VOTING AT AN ELECTION HELD FOR SUCH PURPOSE AS PROVIDED BY LAW; FIXING AN EFFECTIVE DATE; AND CONTAINING OTHER PROVISIONS RELATING THERETO.

Brooks Mitchell, City Manager, advised that Agenda Items No. 3 and 4 are companion items relating to amending the hotel/motel tax ordinance and calling an election to consider increasing the hotel/motel tax from 5% to 8%. Mr. Mitchell stated that the hotel/motel tax is currently used for park development, park improvement, and replacement and maintenance of park equipment. Mr. Mitchell advised that if the tax increase passes the additional 3% could alternatively be used for public transportation. He noted that Oklahoma City recently raised their hotel/motel tax to 9.25% and the City of Norman raised theirs approximately two years ago to 8%. This increase would put us more in line with the surrounding communities.

CONSIDER ADOPTION OF RESOLUTION NO. 108(25) AUTHORIZING THE CALLING AND HOLDING OF AN ELECTION IN THE CITY OF MOORE, OKLAHOMA, FOR THE PURPOSE OF SUBMITTING TO THE REGISTERED QUALIFIED ELECTORS OF SAID CITY THE QUESTION OF THEIR APPROVAL OR REJECTION OF ORDINANCE NO. 1065(25) RELATING TO AN INCREASE IN THE LEVY OF A CITY HOTEL/MOTEL ROOM TAX FROM FIVE PERCENT (5%) TO EIGHT PERCENT (8%); AND CONTAINING OTHER PROVISIONS RELATING THERETO.

Brooks Mitchell, City Manager, noted that this is a hotel/motel tax to be paid by hotel guests and it is not a tax to be paid by all the residents of Moore.

### **Agenda Item Number 5 being:**

CONSIDER AN AMENDMENT TO REZONING APPLICATION NO. RZ-1049 PUD DESIGN STATEMENT TO REDUCE THE NUMBER OF ALLOWED USES TO ONLY THOSE ALLOWED UNDER C-3 GENERAL COMMERCIAL DISTRICT BY RIGHT IN ADDITION TO ESTABLISHMENTS PROVIDING LIGHT AUTOMOTIVE REPAIR, AND REQUIRE 6 OF THE 10 TREES FOR THE LOT TO BE PLACED WITHIN THE LANDSCAPED BUFFER WITH AN AUTOMATIC IRRIGATION SYSTEM, MINIMUM TREE HEIGHT AT MATURITY OF 20' WITH SAID TREES TO BE CLASSIFIED AS EVERGREENS FOR SCREENING PURPOSES.

Elizabeth Weitman, Community Development Director, stated that Agenda Items No. 5 and 6 were heard at the May 5, 2025 City Council Meeting. The items were voted on and it was stated that the items passed; however, it was later determined that there was not a sufficient number of affirmative votes to pass the item due to the absence of three council members. Since this resulted in no action being taken, the items were brought back in order to get a definitive vote on the items.

Ms. Weitman stated that the vacant site is located north of SW 34<sup>th</sup> and east of Santa Fe Avenue and is zoned C-3 General Commercial District. The applicant proposes to develop a commercial space with a light automotive repair shop; however, this use is more intense than is allowed under the C-3 zoning district by right. To achieve the desired development the applicant is requesting a Planned Unit Development ("PUD"). She advised that the applicant is utilizing a PUD to allow the "Automotive and Equipment: Light" use unit classification within the C-3 zoning district. The PUD proposal includes the following amenities and building restrictions:

- Building limited to 1-story in height.
- A minimum 20' landscaping buffer between the east property line and any improvements, such as the parking lot.
- A monument sign will be utilized along SW 34<sup>th</sup> Street with a maximum area of 60 sf per side and a maximum height of 20'.
- No outdoor storage will be allowed at any time.

The Envision Moore 2040 Plan designated this location as Neighborhood Commercial. The application was reviewed as to its conformance with the intent of the Plan. Staff believes the application is in general compliance and an amendment is not necessary due to the amenities and protections offered by the PUD.

Ms. Weitman advised that the application seeks to rezone an undeveloped lot that may not be compatible with surrounding uses in all circumstances, primarily due to the utilization of outdoor storage and the potential for increased light and noise trespass due to normal business operations. In order to address most of these concerns the proposed PUD formalizes an increased greenbelt setback to act as a transitional buffer, height restrictions for the building and monument sign, and a provision for no outdoor storage on the lot. She noted that automotive repair establishments generally generate noise that could impact neighboring residential properties. Therefore, staff conducted sound meter testing at similar businesses and found the average noise generated was within an acceptable level for urban residential areas. She noted that results may vary depending on the operational plan of the establishment.

Ms. Weitman stated that the Planning Commission had numerous discussions regarding protections for the Bluestem Addition. Ultimately the Planning Commission moved to amend the PUD Design Statement to include the following:

- Reduce the number of allowed uses to those listed under the C-3 zoning district as "Uses Permitted by Right" and "Light Automotive Repair" only. This will exclude business uses that are more likely to have noise trespass, such as a car wash, alarm/stereo installer, etc.
- Of the ten trees required by City Code to meet the landscaping requirements, six must be provided in the eastern landscape buffer adjacent to the Bluestem Ridge Addition. These 6 trees must be served by an automatic sprinkler system, must be evergreens for screening purposes, and reach a minimum height of 20' at maturity.

Ms. Weitman advised that the Planning Commission recommended approval of both of the items plus the amendments from the April 2025 meeting. Staff recommends approval of the application contingent upon Council's acceptance of the amendments.

Councilman Williams asked about curb cuts off SW 34<sup>th</sup> Street. Ms. Weitman stated that the applicant was minimizing the curb cuts to two cuts for three lots.

Councilwoman Griffith asked for the hours of operation. Applicant Larry Battison with Battison Properties, 4313 Hackney Wick Road, Norman, Oklahoma advised that the hours of operation would be from 7:30 a.m. to 7:00 p.m. Mr. Battison indicated that he has been in a related business for over 40 years. They have committed to building 15 Bosch facilities in the State of Oklahoma. They chose Moore to be their first and flagship facility. Mr. Battison stated that he would like to address some concerns brought up at the May 5, 2025 meeting. He advised that most independent automotive businesses have an open architecture with a door for every service bay. None of the bays in his business will have a door. There will be one door for entry and one door for exit with a single drive between the bays. Because it will be air conditioned the doors will be shut so the noise level should not be an issue. Mr. Battison commented that traffic was another concern previously mentioned. He felt that traffic would be minimal, particularly in comparison to a retail business or fast-food restaurant that could go on the site.

Councilman Williams asked what type of automotive services his business would offer. Mr. Battison stated that they would do repair work similar to what would be done at a new car dealership. He advised that they would not do body work.

Councilman Williams moved to approve the amendment to Rezoning Application No. RZ-1049 PUD Design Statement to reduce the number of allowed uses to only those allowed under C-3 General Commercial District by right in addition to establishments providing light automotive repair, and require 6 of the 10 trees for the lot to be placed within the landscaped buffer with an automatic irrigation system, minimum tree height at maturity of 20' with said trees to be classified as evergreens for screening purposes, second by Councilwoman Griffith. Motion carried by majority vote.

Sue Wood, Parks and Recreation Director, stated that staff would like to purchase three pallets of Calcium Hypochlorite at a time for the Aquatic Center due to shipping cost savings and storage space.

Councilwoman Hunt moved to approve a contract with Sunbelt Pools for the purchase of Calcium Hypochlorite in the amount of \$13,182.00 per three pallet shipment as the lowest quote, second by Councilwoman Griffith. Motion carried unanimously.

John Parker, Finance Director, stated that the City has utilized Crawford & Associates for a number of years for preparation of financial statements along with various accounting projects throughout the year. Mr. Parker advised that staff is very happy with their service and recommended approval of the engagement letter for the same services over the next fiscal year.

Councilman Williams moved to approve a contract with Crawford & Associates in the estimated amount of \$50,000 for preparation of the City's annual financial statements for fiscal year ended June 30, 2025, and to provide the Finance Department with financial services on special projects on an asneeded basis, second by Councilman Porter. Motion carried unanimously.

CONSIDER ADOPTING RESOLUTION 109(25) PROPOSING AMENDMENTS TO THE CHARTER OF THE CITY OF MOORE, AS AMENDED; CALLING A SPECIAL ELECTION TO SUBMIT THE PROPOSED CHARTER AMENDMENTS TO THE REGISTERED VOTERS OF THE CITY; SETTING THE DATE OF AUGUST 12, 2025 FOR THE SPECIAL ELECTION; AND DIRECTING THAT NOTICE OF THE PROPOSED CHARTER AMENDMENTS AND SPECIAL ELECTION BE GIVEN BY THE CITY CLERK BY PUBLICATION OF NOTICE AS REQUIRED BY LAW.

Brooks Mitchell, City Manager, advised that Agenda Item No. 9 and 10 are companion items. Mr. Mitchell stated that a council committee met several times to discuss proposed Charter changes. Resolution No. 109(25) includes the recommendations from the committee. The proposed changes include the following:

- Section 2-3. Increases the Mayor's salary from \$200 to \$500 and the Council's salary from \$100 to \$200 beginning with their next term.
- Section 4-1. Removes the designation of the City Clerk as the head of the Department of Finance and revises language to reflect current job functions.
- Section 4-2. Designates the Finance Director as the City Treasurer.
- Section 4-4. Changes the sale of City property valued at over \$25,000, which must be approved by residents or non-emergency ordinance, to \$75,000.
- Section 8-2. Removes the Personnel Board Section 8-4. Removes the Personnel Board
- Section 8-3. Extends a classified service designation for employees that aren't specifically exempt. Those individuals would include the City Manager, Council Members, and the City Manager's Assistant.
- Section 2-1. Establishes qualifications to serve on the council which include being a citizen of the United States and the State of Oklahoma, be at least 25 years old, reside in the City of Moore or an area annexed into the City for one year. For a Councilman-at-Large position they must be a registered voter and have a Moore address for at least one year preceding the filing of a Declaration of Candidacy. Councilman position representing a ward they must be a registered voter within the ward for at least one year preceding the filing of a Declaration of Candidacy.

Councilman Williams asked if the concerns of Justus Chandler, who spoke at the May 5, 2025 City Council meeting, had been addressed. Mr. Chandler advised that there was a Supreme Court ruling that states a City cannot include a freeholder clause in the City Charter. Mr. Mitchell indicated that the proposed Charter changes would address the issue.

Councilman Porter asked if the proposed hotel/motel tax increase discussed under Agenda Items No. 3 and 4 would be on the same ballot as the Charter changes. Mr. Mitchell confirmed that the proposed hotel/motel tax increase and Charter changes would be on the August 12, 2025 election ballot.

Mayor Hamm noted that if the Charter changes are approved by the voters, the City Council would not benefit from the pay increase until they begin a new term of office.

At all times, Grantee shall maintain continuous, uninterrupted two-way access through the driveways.
Ingress and Egress access driveways shall be constructed $\frac{1}{2}$ at a time to permit two-way vehicular access at all times.
Grantor's existing improvements within the premises shall remain in their present location and Grantee shall not require their removal or relocation as a result of this easement. 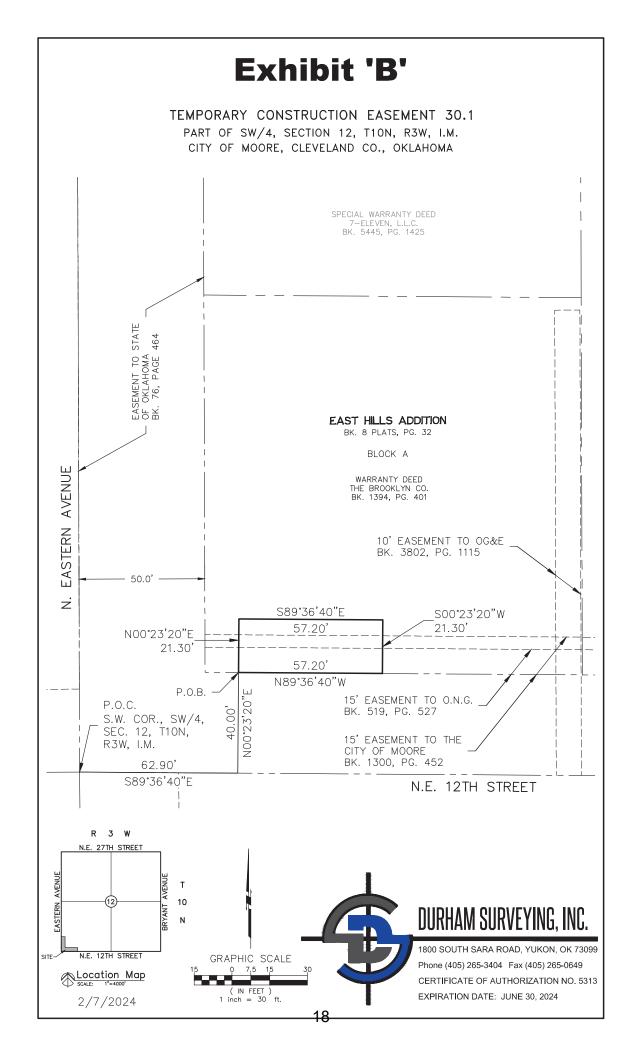

# Renewal of Scope of Work and Fees Traffic Signal Central System Management

- 1) **SSM** will maintain communications and monitor traffic signal operations from July 1, 2025 through June 30, 2026 at the following intersections:
  - S.W. 19<sup>th</sup> St. & Santa Fe Ave.
  - S.W. 19<sup>th</sup> St. & Eagle Dr.
  - S.W. 19<sup>th</sup> St. & Fritts Blvd/Max Morgan Blvd.
  - S.W. 19<sup>th</sup> St. & Telephone Rd.
  - S.W. 19<sup>th</sup> St. & Riverwalk Dr.
  - S.W. 19<sup>th</sup> St. & I-35 West Frontage Rd.
  - S.W. 19<sup>th</sup> St. & I-35 East Frontage Rd.
  - S.W. 19<sup>th</sup> St. & Broadway Ave.
  - S.W. 19<sup>th</sup> St. & Tower Dr.
- 2) SSM will contract with Verizon for cellular service to each modem. SSM will be responsible for connecting the controller through the modem to the Central ATMS.NOW system hosted by SSM. The monthly and annual costs for the data usage on Verizon will be the responsibility of SSM.
- 3) **SSM** will maintain a backup of the each traffic signal controller data files. The data files will be kept throughout the length of the contract so that it can be downloaded at any time in the future to place the intersection back into operation as it was operating prior to Consultant involvement at the direction of the **City of Moore**.
- 4) **SSM** will review local timing parameters in the controllers. Examples include the minimum green, extension timing, maximum timings dual entry, simultaneous gap etc. **SSM** will also review with the **City of Moore** their policy for setting the Yellow, All Red times, Walk times, Don't Walk times and any other local timing parameters for which the **City of Moore** has a policy. If changes are recommended and agreed to by the **City of Moore**, **SSM** will advise the **City of Moore** and receive written approval before making changes. The current national policy requires all pedestrian phases to have a minimum of 5 seconds walk time and the Don't Walk time shall be calculated based on a 3.5 feet per second walking time and the length of the crosswalk. If the **City of Moore** has a written policy other than the requirements, it should be supplied to **SSM** with written instructions to adhere to the **City of Moore's** policy. In the absence of a policy, **SSM** will change all Walk times to 7 seconds and calculate and implement the correct Don't Walk Times in accordance with the latest Institute of Transportation Engineers policy on pedestrian clearance times.



- 5) If recent turning movement counts are available from the **City of Moore** and supplied to **SSM**, or from **SSM**, the counts will be used to review the existing coordination timing. If turning movement counts are not available and revised timing plans are determined to be needed, **SSM** will use the "Split History Reports" within ATMS.NOW to establish the appropriate split times and timing parameters for coordination plans for weekdays, and weekends if coordination is desired by the **City of Moore** for the weekends. The times of day the **City of Moore** would like to see coordination implemented will be discussed and a plan established cooperatively with the **City of Moore** and **SSM** with **SSM's** recommendations.
- 6) A Synchro model will be constructed for the intersections to be coordinated. All phasing and phase numbers will be field verified and the model will match the field phasing. The model will match all signal head displays in the field. The completed model will be available and supplied to the **City of Moore** at any time if requested.
- 7) Either using the turning movement counts or the "Split History Reports" a model will be constructed for each timing plan to be implemented. If "Split History Reports" are used, **SSM** has a proprietary software program that calculates the split times for the "Split History Report" with proven accuracy. **SSM** will discuss with the **City of Moore** whether the split times can be shorter than the minimum time required to allow a full Walk time, Don't Walk time, Yellow, and Red. If the **City of Moore** prefers the split times to be long enough to time this minimum period, the split times will be implemented accordingly. If shorter split times can be used resulting in shorter cycle lengths, the ATMS.NOW system is capable of this feature. When there is a pedestrian actuation with shorter split times, the traffic signal will hold for the Walk and Don't Walk times and then transition back into coordination. The split times will be further adjusted during field implementation.
- 8) **SSM** will continue to maintain the coordination database in ATMS.NOW. Each timing plan (including split times, offset times, and cycle length times) will continue to frequently be checked in the field and adjusted as necessary to meet traffic demand. Time of Day plans and an Annual Schedule will also be maintained. All field changes will be uploaded to the central system to keep an accurate database.
- 9) Timing plans for the 5 basic Holidays (New Year's Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, and Christmas Day) will remain in place.
- 10) SSM will continue to monitor errors received from ATMS. Now pertaining to the operation of the system including communication errors, coordination errors, detection issues, if the signal goes to flash and a number of other alarms. If the errors are coordination errors, SSM will fix them. If the errors are hardware related, SSM will contact the City of Moore or their assigned contractor



as to the issue that needs to be resolved. One advantage of a central system is early notification of signal malfunctions.

- 11) **SSM** will continue to monitor the system on a periodic basis to assure proper operation.
- 12) If at any time, the **City of Moore** desires a change in the basic operation of the system, **SSM** will work with the **City of Moore** to make the changes. **SSM** will implement up to two "Special Event" plans for the **City of Moore** if requested. A "Special Event" might be a regional craft show, regional festival, or Black Friday. These events might substantially increase traffic in the corridor. If more than two "Special Event" plans are required, the **City of Moore** and **SSM** will agree in writing as to the additional cost to implement the plans.
- 13) Throughout the year, during normal business hours, **SSM** will be available to answer any questions the **City of Moore** may have and make changes as needed requested by the **City of Moore**.
- 14) Annually, after renewal of the Maintenance Contract, **SSM** will check "Split History Reports" and retime the system if necessary.
- 15) SSM shall be responsible for the operation of the server, the communications link, and the modem. The City of Moore shall be responsible for all other hardware. If it is determined a modem needs to be changed, SSM will install a new modem after concurrence from the City of Moore. The cost to either repair the existing modem or the replacement cost will be the responsibility of the City of Moore. SSM will stock spare modems. SSM will loan a modem to the City of Moore until either the existing modem can be repaired or is replaced. SSM will notify the City of Moore in advance of any charges for either the repair or replacement of the modem.

### **Fees**

The "Monthly Monitoring Costs" can be paid either monthly or annually at the beginning of the period at the **City of Moore's** option. This agreement shall be in force for a period of one year from the start date of the "Monthly Monitoring Costs".

Sixty days prior to the end of the agreement, **SSM** will notify the **City of Moore** of the expiration date. A new agreement will be submitted for the **City of Moore's** execution if they desire to continue the agreement.



### **Monthly Monitoring Costs**

The "Monthly Monitoring Costs" are \$17,520 annually or \$1,460 per month. The city may choose to pay monthly or annually. The fee is due at either the beginning of the monitoring (annually) or the beginning of the month.

#### ORDINANCE NO. 37.25

AN ORDINANCE AMENDING PART 12, CHAPTER 4, ARTICLE G LANDSCAPING REGULATIONS OF THE MOORE CITY CODE BY AMENDING SECTION 12-458 "MAINTENANCE OF LANDSCAPING" ESTABLISHING ENFORCEMENT PROCEDURES FOR REQUIRED LANDSCAPING; AND ADDING SECTION 12-458.1 "ABATEMENT OF LANDSCAPING VIOLATIONS" ESTABLISHING ACTIONS TO BE TAKEN WHEN ABATING LANDSCAPING VIOLATIONS; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEALER.

Be it ordained by the Mayor and the Council of the City of Moore, Oklahoma that Part 12, Chapter 4, Article G, shall be amended as follows:

#### Sec 12-458 Maintenance Of Landscape

- It shall be the responsibility of the property owner to maintain in good condition all the improvements <u>landscaping</u> required by this section. Any required fence or screening that are damaged shall be repaired, and any vegetation that dies <u>or is otherwise removed</u> shall be replaced no later than the following planting season (spring or fall), being November 15th to March 15th of each year.
- 2. When it is determined by the community development director, or his their designee, that improvements landscaping required by this section are is not being maintained, it shall be his their duty to give notice in writing to the property owner and the tenant(s) on record. Such notice shall specify in what manner the improvements landscaping are is in need of maintenance and a date for compliance. The property owner shall have not less than 30 days to comply with the notice; provided, however, that any person aggrieved by any such order or disagreeing with any of the requirements of the notice, may file an appeal within the 30-day period to the board of adjustment. unless a compliance plan is approved by the community development director, or their designee.
- 3. Failure to provide <u>or maintain</u> the <u>improvements <u>landscaping</u> required by this Code or <u>failure to maintain required improvements in the manner prescribed by this Code</u> shall constitute an offense and violation of this Code and shall be subject to <u>the penalties as provided in Section 1-108</u> <u>one or more of the following penalties:</u></u>
  - a. A Certificate of Occupancy may be withheld for a commercial building which fails to provide or maintain the landscaping requirements contained within this Article; and/or
  - b. The City may cause dead or diseased landscaping to be removed and new landscaping installed that meets the requirements of this code or may cause new landscaping that meets the requirements of this code to be installed where required landscaping is missing. The cost of such improvements, including an administrative fee of three-hundred dollars (\$300.00), shall be placed on the water bill of the business; and/or
  - c. A citation may be issued in accordance with Section 1-108 for each day dead, diseased or missing landscaping is maintained or allowed to exist on the property.

#### Sec 12-458.1 Abatement Of Landscaping Violations

- 1. The City may cause dead or diseased landscaping to be removed and new landscaping installed that meets the requirements of this code or may cause new landscaping that meets the requirements of this code to be installed where required landscaping is missing in accordance with the following procedure:
  - a. At least thirty days' notice shall be given to the owner of the property before the city takes action. A copy of the notice shall be posted on the property to be affected. In addition, a copy of the notice shall be sent by mail to the property owner at the address shown by the current year's tax rolls in the office of the county treasurer. At the time of mailing of the notice to any property owner, the city shall obtain a receipt of mailing from the postal service, which shall indicate the date of mailing and the name and address of the mailee. However, if the property owner cannot be located, notice may be given by posting a copy of the notice on the property, or by publication, as defined by 11 O.S. § 1-102. Such notice may be published once not less than thirty days prior to any action to be taken pursuant to this section;
  - b. After 30-days notice, if said landscaping is not removed and replaced, or in the event of missing landscaping, installed per the requirements of this code, the community development director or their designee may cause the dead or diseased landscaping to be removed, and/or may cause missing landscaping to be installed meeting the requirements of this Article and shall fix reasonable dates for the commencement and completion of the work. The community development director or their designee shall direct the removal and installation of the required landscaping be done by a private contractor who is the lowest and best bidder or quote.
  - c. After the landscaping has been removed and/or installed, the community development director or designee shall determine the actual cost of such action and any other expenses as may be necessary in conjunction therewith, including an administrative fee of three-hundred dollars (\$300.00). The community development director or designee shall forward a statement of such actual cost attributable to the removal and/or planting and a demand for payment by mail to the property owner at the address specified in this section. The city shall obtain a receipt of mailing from the postal service, which receipt shall indicate the date of mailing and the name and address of the mailee.
  - d. If payment is not made within thirty-days from the date of the mailing of the statement, the community development director or designee shall cause such costs to be placed on the property's water bill to be paid at the next month's billing to be paid in installments over 90-days unless other terms are agreed upon by the community development director, or their designee.

### Severability

If any of the provisions of this ordinance are determined to be unconstitutional or unlawful by any court of competent jurisdiction, the remainder shall be severable and unaffected.

#### Repealer

Any ordinance or parts thereof in conflict with this section are hereby repealed.

- § 1.2 This Master Agreement shall apply to all Service Orders agreed to by the Parties within the term of this Master Agreement until completion of the Service Order. In the event of a conflict between terms and conditions of this Master Agreement and a Service Order, the terms of the Service Order shall take precedence for the services provided pursuant to the Service Order. An agreed upon Service Order together with this Master Agreement form a Service Agreement. A Service Agreement represents the entire and integrated agreement between the parties, and supersedes prior negotiations, representations, or agreements, either written or oral. A Service Agreement may be amended or modified only by a Modification.
- § 1.3 This Master Agreement will renew on an annual basis, on the day and month of the Date of this Master Agreement, unless either party provides notice of their intent not to renew this Master Agreement. Notice must be provided at least 60 days prior to the renewal date. In the event either party elects not to renew this Master Agreement, the terms of this Master Agreement shall remain applicable until all Service Orders under this Master Agreement are completed or terminated.
- § 1.4 The Owner identifies the following representative authorized to act on the Owner's behalf with respect to this Master Agreement:

- § 1.4.1 In each Service Order, the Owner will identify a representative authorized to act on the Owner's behalf with respect to the Service Order.
- § 1.5 The Architect identifies the following representative authorized to act on the Architect's behalf with respect to this Master Agreement:

- § 1.5.1 In each Service Order, the Architect will identify a representative authorized to act on behalf of the Architect with respect to the Service Order.
- § 1.6 Nothing contained in this Master Agreement or in a Service Order shall create a contractual relationship with, or a cause of action in favor of, a third party against either the Owner or Architect.

#### ARTICLE 2 SERVICE ORDERS

- § 2.1 The Owner is not required to issue any Service Orders under this Master Agreement. Upon request, the Architect may submit Service Orders to Owner for approval.
- § 2.2 The Architect may decline to accept any Service Order issued by the Owner.
- § 2.3 The Architect shall perform the services set forth in each agreed upon Service Order, consisting of AIA Document B221-2018, Service Order, or such other document as the Owner and Architect may mutually agree upon. Each Service Order shall state the name, location, and detailed description of the Project; describe the Architect's Services; state the Architect's compensation; and list the attachments and exhibits incorporated by reference.

#### ARTICLE 3 ARCHITECT'S RESPONSIBILITIES

- § 3.1 The Architect shall perform its services consistent with the professional skill and care ordinarily provided by architects practicing in the same or similar locality under the same or similar circumstances. The Architect shall perform its services as expeditiously as is consistent with such professional skill and care and the orderly progress of the services provided pursuant to a Service Agreement.
- § 3.2 Except with the Owner's knowledge and consent, the Architect shall not engage in any activity, or accept any employment, interest or contribution that would reasonably appear to compromise the Architect's professional judgment with respect to this Master Agreement or any Service Agreement.
- § 3.3 The Architect shall maintain the following insurance until termination of this Master Agreement. If any of the requirements set forth below are in addition to the types and limits the Architect normally maintains, the Owner shall pay the Architect as set forth in Section 9.4.
- (Identify types and limits of insurance coverage, and other insurance requirements applicable to the Agreement, if any.)

#### 3.3.1 General Liability

Commercial General Liability with policy limits of not less than One million (\$1,000,000.00) for each occurrence and Two million (2,000,000.00) in the aggregate for bodily injury and property damage.

#### 3.3.2 Automobile Liability

Automobile Liability covering vehicles owned, and non-owned vehicles used, by the Architect with policy limits of not less than One million (\$1,000,000.00 per accident for bodily injury, death of any person, and property damage arising out of the ownership, maintenance and use of those motor vehicles, along with any other statutorily required automobile coverage.

**3.3.3** The Architect may achieve the required limits and coverage for Commercial General Liability and Automobile Liability through a combination of primary and excess or umbrella liability insurance, provided such primary and excess or umbrella liability insurance policies result in the same or greater coverage as the coverages required under Sections 3.3.1 and 3.3.2, and in no event shall any excess or umbrella liability insurance provide narrower coverage than the primary policy. The excess policy shall not require the exhaustion of the underlying limits only through the actual payment by the underlying insurers.

#### 3.3.4 Workers' Compensation

#### 3.3.5 Employers Liability

Employers Liability with policy limits not less than Five hundred thousand (\$500,000.00) each accident, Five hundred thousand (\$500,000.00) each employee, and Five hundred thousand (\$500,000.00) policy limit.

#### 3.3.6 Professional Liability

Policy limits of not less than Two million (\$2,000,000.00) per claim and Two million (\$2,000,00000) in the aggregate.

- § 3.4 The Architect shall coordinate its services with those services provided by the Owner and the Owner's consultants. The Architect shall be entitled to rely on the accuracy and completeness of the services and information furnished by the Owner and the Owner's consultants. The Architect shall provide prompt written notice to the Owner if the Architect becomes aware of any error, omission, or inconsistency in such services or information.
- § 3.5 The Architect shall not be responsible for an Owner's directive or substitution made without the Architect's approval.

#### ARTICLE 4 ADDITIONAL SERVICES

- § 4.1 The Architect may provide Additional Services after execution of a Service Order without invalidating the Service Agreement. Except for services required due to the fault of the Architect, any Additional Services provided in accordance with this Article 4 shall entitle the Architect to compensation pursuant to Section 9.3.
- § 4.2 Unless otherwise provided in a Service Order, upon recognizing the need to perform the following Additional Services, as they relate to the services provided pursuant to the Service Order, the Architect shall notify the Owner with reasonable promptness and explain the facts and circumstances giving rise to the need. The Architect shall not proceed to provide the following Additional Services until the Architect receives the Owner's written authorization:
  - .1 Services necessitated by a change in the Initial Information, previous instructions or approvals given by the Owner, or a material change in the Project including size, quality, complexity, the Owner's schedule or budget for Cost of the Work, or procurement or delivery method;
  - .2 Services necessitated by the enactment or revision of codes, laws, or regulations, including changing or editing previously prepared Instruments of Service;
  - .3 Changing or editing previously prepared Instruments of Service necessitated by official interpretations of applicable codes, laws or regulations that are either (a) contrary to specific interpretations by the applicable authorities having jurisdiction made prior to the issuance of the building permit, or (b) contrary to requirements of the Instruments of Service when those Instruments of Service were prepared in accordance with the applicable standard of care;
  - .4 Services necessitated by decisions of the Owner not rendered in a timely manner or any other failure of performance on the part of the Owner or the Owner's consultants or contractors;
  - .5 Preparing digital models or other design documentation for transmission to the Owner's consultants and contractors, or to other Owner-authorized recipients;
  - .6 Preparation of design and documentation for alternate bid or proposal requests proposed by the Owner:
  - .7 Preparation for, and attendance at, a public presentation, meeting or hearing;
  - .8 Preparation for, and attendance at, a dispute resolution proceeding or legal proceeding, except where the Architect is party thereto;
  - .9 Evaluation of the qualifications of entities providing bids or proposals; or
  - .10 Consultation concerning replacement of Work resulting from fire or other cause during construction.

#### ARTICLE 5 OWNER'S RESPONSIBILITIES

- § 5.1 The Owner shall provide information in a timely manner regarding requirements for and limitations of each Service Order.
- § 5.2 The Owner shall render decisions and approve the Architect's submittals in a timely manner in order to avoid unreasonable delay in the orderly and sequential progress of the Architect's services.

- § 5.3 The Owner shall coordinate the services of its own consultants with those services provided by the Architect. Upon the Architect's request, the Owner shall furnish copies of the scope of consulting services in the contracts between the Owner and the Owner's consultants. The Owner shall furnish the services of consultants as designated in an individual Service Order, or authorize the Architect to furnish them as an Additional Service, when the Architect requests such services and demonstrates that they are reasonably required by the scope of the Service Order. The Owner shall require that its consultants and contractors maintain insurance, including professional liability insurance, as appropriate to the services or work provided.
- § 5.4 The Owner shall furnish all legal, insurance, and accounting services, including auditing services, that may be reasonably necessary at any time to meet the Owner's needs and interests under a Service Agreement.
- § 5.5 The Owner shall provide prompt written notice to the Architect if the Owner becomes aware of any fault or defect in the services or work related to a Service Agreement, including errors, omissions or inconsistencies in the Architect's Instruments of Service.
- § 5.6 Within 15 days after receipt of a written request from the Architect, the Owner shall furnish the requested information as necessary and relevant for the Architect to evaluate, give notice of, or enforce lien rights.

#### ARTICLE 6 COPYRIGHTS AND LICENSES

- § 6.1 The Architect and the Owner warrant that in transmitting Instruments of Service, or any other information, the transmitting party is the copyright owner of such information or has permission from the copyright owner to transmit such information for its use in relation to a Service Agreement.
- § 6.2 The Architect and the Architect's consultants shall be deemed the authors and owners of their respective Instruments of Service, including the Drawings and Specifications, and shall retain all common law, statutory and other reserved rights, including copyrights. Submission or distribution of Instruments of Service to meet official regulatory requirements or for similar purposes in connection with a Service Agreement is not to be construed as publication in derogation of the reserved rights of the Architect and the Architect's consultants.
- § 6.3 The Architect grants to the Owner a nonexclusive license to use the Architect's Instruments of Service solely and exclusively for purposes of constructing, using, maintaining, altering and adding to the Project, provided that the Owner substantially performs its obligations under the Service Agreement, including prompt payment of all sums when due pursuant to Articles 8 and 9. The Architect shall obtain similar nonexclusive licenses from the Architect's consultants consistent with this Master Agreement. The license granted under this section permits the Owner to authorize the Contractor, Subcontractors, Sub-subcontractors, and suppliers, as well as the Owner's consultants and separate contractors, to reproduce applicable portions of the Instruments of Service, subject to any protocols established pursuant to Section 10.9, solely and exclusively for use in performing services or construction for the Project. If the Architect rightfully terminates a Service Agreement for cause as provided in Section 8.4, the license granted in this Section 6.3, and related to the terminated Service Agreement, shall terminate.
- § 6.3.1 In the event the Owner uses the Instruments of Service without retaining the authors of the Instruments of Service, the Owner releases the Architect and Architect's consultant(s) from all claims and causes of action arising from such uses. The Owner, to the extent permitted by law, further agrees to indemnify and hold harmless the Architect and its consultants from all costs and expenses, including the cost of defense, related to claims and causes of action asserted by any third person or entity to the extent such costs and expenses arise from the Owner's use of the Instruments of Service under this Section 6.3.1. The terms of this Section 6.3.1 shall not apply if the Owner rightfully terminates this Agreement for cause under Section 8.4.
- § 6.4 Except for the licenses granted in this Article 6, no other license or right shall be deemed granted or implied under this Master Agreement. The Owner shall not assign, delegate, sublicense, pledge or otherwise transfer any license granted herein to another party without the prior written agreement of the Architect. Any unauthorized use of the Instruments of Service shall be at the Owner's sole risk and without liability to the Architect and the Architect's consultants.
- § 6.5 Except as otherwise stated in Section 6.3, the provisions of this Article 6 shall survive the termination of this Master Agreement.

#### ARTICLE 7 CLAIMS AND DISPUTES

#### § 7.1 General

- § 7.1.1 The Owner and Architect shall commence all claims and causes of action against the other and arising out of or related to any Service Agreement, whether in contract, tort, or otherwise, in accordance with the requirements of the binding dispute resolution method selected in this Master Agreement and within the period specified by applicable law, but in any case not more than 10 years after the completion of the services provided pursuant to a specific Service Agreement, whichever is sooner. Completion of the services pursuant to a specific Service Agreement shall be the date of Substantial Completion of construction related to the services performed pursuant to the Service Agreement or, where there is no construction work related to a Service Agreement, the date the Architect completes its services under the Service Agreement. The Owner and Architect waive all claims and causes of action not commenced in accordance with this Section 7.1.1.
- § 7.1.2 To the extent damages are covered by property insurance, the Owner and Architect waive all rights against each other and against the contractors, consultants, agents, and employees of the other for damages, except such rights as they may have to the proceeds of such insurance as set forth in AIA Document A201<sup>TM</sup>\_2017, General Conditions of the Contract for Construction. The Owner or the Architect, as appropriate, shall require of the contractors, consultants, agents, and employees of any of them, similar waivers in favor of the other parties enumerated herein.
- § 7.1.3 The Architect and Owner waive consequential damages for claims, disputes, or other matters in question, arising out of or relating to a Service Agreement. This mutual waiver is applicable, without limitation, to all consequential damages due to either party's termination of a Service Agreement, except as specifically provided in Section 8.6.

#### § 7.2 Mediation

- § 7.2.1 Any claim, dispute or other matter in question arising out of or related to a Service Agreement shall be subject to mediation as a condition precedent to binding dispute resolution. If such matter relates to or is the subject of a lien arising out of the Architect's services, the Architect may proceed in accordance with applicable law to comply with the lien notice or filing deadlines prior to resolution of the matter by mediation or by binding dispute resolution.
- § 7.2.2 The Owner and Architect shall endeavor to resolve claims, disputes and other matters in question between them by mediation, which, unless the parties mutually agree otherwise, shall be administered by the American Arbitration Association in accordance with its Construction Industry Mediation Procedures in effect on the date of this Master Agreement. A request for mediation shall be made in writing, delivered to the other party to this Master Agreement, and filed with the person or entity administering the mediation. The request may be made concurrently with the filing of a complaint or other appropriate demand for binding dispute resolution but, in such event, mediation shall proceed in advance of binding dispute resolution proceedings, which shall be stayed pending mediation for a period of 60 days from the date of filing, unless stayed for a longer period by agreement of the parties or court order. If an arbitration proceeding is stayed pursuant to this section, the parties may nonetheless proceed to the selection of the arbitrator(s) and agree upon a schedule for later proceedings.
- § 7.2.3 The parties shall share the mediator's fee and any filing fees equally. The mediation shall be held in the place where the Project is located, unless another location is mutually agreed upon. Agreements reached in mediation shall be enforceable as settlement agreements in any court having jurisdiction thereof.
- § 7.2.4 If the parties do not resolve a dispute through mediation pursuant to this Section 7.2, the method of binding dispute resolution shall be the following: (Check the appropriate box.)

If the Owner and Architect do not select a method of binding dispute resolution, or do not subsequently agree in writing to a binding dispute resolution method other than litigation, the dispute will be resolved in a court of competent jurisdiction.

#### § 7.3 Arbitration

- § 7.3.1 If the parties have selected arbitration as the method for binding dispute resolution in this Master Agreement, any claim, dispute or other matter in question arising out of or related to a Service Agreement subject to, but not resolved by, mediation shall be subject to arbitration, which, unless the parties mutually agree otherwise, shall be administered by the American Arbitration Association in accordance with its Construction Industry Arbitration Rules in effect on the date of this Master Agreement. A demand for arbitration shall be made in writing, delivered to the other party to this Master Agreement, and filed with the person or entity administering the arbitration.
- § 7.3.1.1 A demand for arbitration shall be made no earlier than concurrently with the filing of a request for mediation, but in no event shall it be made after the date when the institution of legal or equitable proceedings based on the claim, dispute or other matter in question would be barred by the applicable statute of limitations. For statute of limitations purposes, receipt of a written demand for arbitration by the person or entity administering the arbitration shall constitute the institution of legal or equitable proceedings based on the claim, dispute or other matter in question.
- § 7.3.2 The foregoing agreement to arbitrate, and other agreements to arbitrate with an additional person or entity duly consented to by parties to this Master Agreement, shall be specifically enforceable in accordance with applicable law in any court having jurisdiction thereof.
- § 7.3.3 The award rendered by the arbitrator(s) shall be final, and judgment may be entered upon it in accordance with applicable law in any court having jurisdiction thereof.

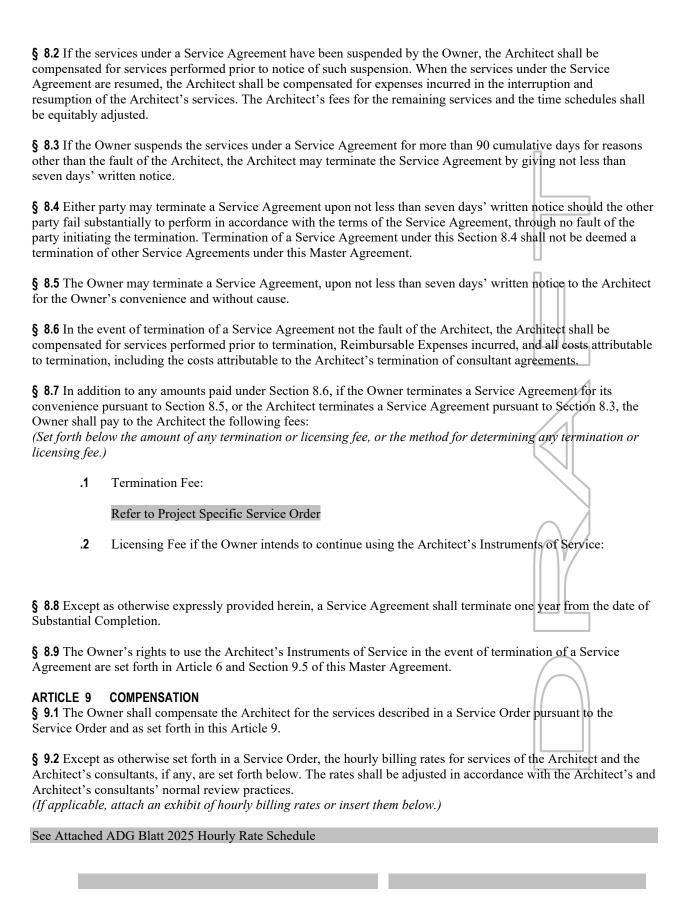
#### § 7.3.4 Consolidation or Joinder

- § 7.3.4.1 Either party, at its sole discretion, may consolidate an arbitration conducted under this Master Agreement with any other arbitration to which it is a party provided that (1) the arbitration agreement governing the other arbitration permits consolidation; (2) the arbitrations to be consolidated substantially involve common questions of law or fact; and (3) the arbitrations employ materially similar procedural rules and methods for selecting arbitrator(s).
- § 7.3.4.2 Either party, at its sole discretion, may include by joinder persons or entities substantially involved in a common question of law or fact whose presence is required if complete relief is to be accorded in arbitration, provided that the party sought to be joined consents in writing to such joinder. Consent to arbitration involving an additional person or entity shall not constitute consent to arbitration of any claim, dispute or other matter in question not described in the written consent.
- § 7.3.4.3 The Owner and Architect grant to any person or entity made a party to an arbitration conducted under this Section 7.3, whether by joinder or consolidation, the same rights of joinder and consolidation as the Owner and Architect under this Master Agreement.
- § 7.4 The provisions of this Article 7 shall survive the termination of a Service Agreement.

#### ARTICLE 8 TERMINATION OR SUSPENSION OF SERVICE AGREEMENTS

§ 8.1 If the Owner fails to make payments to the Architect in accordance with a Service Agreement, such failure shall be considered substantial nonperformance and cause for termination of the Service Agreement or, at the Architect's option, cause for suspension of performance of services under the Service Agreement for which the Owner failed to make payment. If the Architect elects to suspend services, the Architect shall give seven days' written notice to the Owner before suspending services. In the event of a suspension of services, the Architect shall have no liability to the Owner for delay or damage caused the Owner because of such suspension of services. Before resuming services, the Owner shall pay the Architect all sums due prior to suspension and any expenses incurred in the interruption and resumption of the Architect's services. The Architect's fees for the remaining services and the time schedules shall be equitably adjusted.

#### § 9.4 Compensation for Reimbursable Expenses

- § 9.4.1 Reimbursable Expenses are in addition to compensation for the Architect's professional services and include expenses incurred by the Architect and the Architect's consultants directly related to a Service Agreement, as follows:
  - .1 Transportation and authorized out-of-town travel and subsistence;
  - **.2** Long distance services, dedicated data and communication services, teleconferences, Project web sites, and extranets;
  - .3 Permitting and other fees required by authorities having jurisdiction over the Project;
  - .4 Printing, reproductions, plots, and standard form documents;
  - .5 Postage, handling, and delivery;
  - .6 Expense of overtime work requiring higher than regular rates, if authorized in advance by the Owner;
  - .7 Renderings, physical models, mock-ups, professional photography, and presentation materials requested by the Owner or required for the Project;
  - .8 If required by the Owner, and with the Owner's prior written approval, the Architect's consultant's expense of professional liability insurance dedicated exclusively to the Project, or the expense of additional insurance coverage or limits in excess of that normally maintained by the Architect or the Architect's consultants, and disclosed by the Architect in writing prior to execution of this Master Agreement or a related Service Agreement;
  - .9 All taxes levied on professional services and on reimbursable expenses;
  - .10 Site office expenses; and
  - .11 Other similar Project-related expenditures.
- § 9.4.2 For Reimbursable Expenses the compensation shall be the expenses incurred by the Architect and the Architect's consultants plus one and fifteen hundredths' percent (1.15 %) of the expenses incurred.
- § 9.4.3 Reimbursable Expenses will be allocated to each Service Agreement.

#### § 9.5 Payments to the Architect

#### § 9.5.1 Progress Payments

§ 9.5.1.1 Unless otherwise agreed, payments for services provided pursuant to a Service Agreement shall be made monthly in proportion to services performed. Payments are due and payable upon presentation of the Architect's invoice. Amounts unpaid thirty (30) days after the invoice date shall bear interest at the rate entered below, or in the absence thereof at the legal rate prevailing from time to time at the principal place of business of the Architect. (Insert rate of monthly or annual interest agreed upon.)

- § 9.5.1.2 The Owner shall not withhold amounts from the Architect's compensation to impose a penalty or liquidated damages on the Architect, or to offset sums requested by or paid to contractors for the cost of changes in the Work unless the Architect agrees or has been found liable for the amounts in a binding dispute resolution proceeding. In any event, the Owner shall not withhold payments to the Architect pertaining to a Service Agreement to offset amounts in dispute under a separate Service Agreement.
- § 9.5.1.3 Records of Reimbursable Expenses, expenses pertaining to Additional Services, and services performed on the basis of hourly rates shall be available to the Owner at mutually convenient times.

#### ARTICLE 10 MISCELLANEOUS PROVISIONS

§ 10.1 Each Service Agreement shall be governed by the law of the place where the Project described in the Service Order is located, excluding that jurisdiction's choice of law rules. If the parties have selected arbitration as the method of binding dispute resolution, the Federal Arbitration Act shall govern Section 7.3.

- § 10.2 Notice shall be provided in writing to the designated representative of the party to whom the notice is addressed and shall be deemed to have been duly served if delivered in person, by mail, by courier, or by electronic transmission.
- § 10.3 The Owner and Architect, respectively, bind themselves, their agents, successors, assigns, and legal representatives to each Service Agreement. Neither the Owner nor the Architect shall assign a Service Agreement without the written consent of the other, except that the Owner may assign a Service Agreement to a lender providing financing for the Project if the lender agrees to assume the Owner's rights and obligations under the Service Agreement, including any payments due to the Architect by the Owner prior to the assignment.
- § 10.4 If the Owner requests the Architect to execute certificates, the proposed language of such certificates shall be submitted to the Architect for review at least 14 days prior to the requested dates of execution. If the Owner requests the Architect to execute consents reasonably required to facilitate assignment to a lender, the Architect shall execute all such consents that are consistent with the Service Agreement, provided the proposed consent is submitted to the Architect for review at least 14 days prior to execution. The Architect shall not be required to execute certificates or consents that would require knowledge, services, or responsibilities beyond the scope of the Service Agreement.
- § 10.5 Unless otherwise required in a Service Agreement, the Architect shall have no responsibility for the discovery, presence, handling, removal or disposal of, or exposure of persons to, hazardous materials or toxic substances in any form at the Project site.
- § 10.6 The Architect shall have the right to include photographic or artistic representations of the design of the Projects for which services are performed among the Architect's promotional and professional materials. The Architect shall be given reasonable access to the completed Projects to make such representations. However, the Architect's materials shall not include the Owner's confidential or proprietary information if the Owner has previously advised the Architect in writing of the specific information considered by the Owner to be confidential or proprietary. The Owner shall provide professional credit for the Architect in the Owner's promotional materials for the Projects. This Section 10.6 shall survive the termination of a Service Agreement unless the Owner terminates a Service Agreement for cause pursuant to Section 8.4.
- § 10.7 If the Architect or Owner receives information specifically designated as "confidential" or "business proprietary," the receiving party may disclose such information as required by law or court order, including a subpoena or other form of compulsory legal process issued by a court or governmental entity. The Party receiving such information may also disclose it to its employees, consultants or contractors in order to perform services or work solely and exclusively for the Project, provided those employees, consultants and contractors are subject to the restrictions on the disclosure and use of such information as set forth in this Section 10.7.
- § 10.8 The invalidity of any provision of the Agreement shall not invalidate the Agreement or its remaining provisions. If it is determined that any provision of the Agreement violates any law, or is otherwise invalid or unenforceable, then that provision shall be revised to the extent necessary to make that provision legal and enforceable. In such case the Agreement shall be construed, to the fullest extent permitted by law, to give effect to the parties' intentions and purposes in executing the Agreement.
- § 10.9 The parties shall agree upon protocols governing the transmission and use of Instruments of Service or any other information or documentation in digital form. The parties will use AIA Document E203<sup>TM</sup>—2013, Building Information Modeling and Digital Data Exhibit, to establish the protocols for the development, use, transmission, and exchange of digital data.
- § 10.9.1 Any use of, or reliance on, all or a portion of a building information model without agreement to protocols governing the use of, and reliance on, the information contained in the model and without having those protocols set forth in AIA Document E203<sup>TM</sup>\_2013, Building Information Modeling and Digital Data Exhibit, and the requisite AIA Document G202<sup>TM</sup>\_2013, Project Building Information Modeling Protocol Form, shall be at the using or relying party's sole risk and without liability to the other party and its contractors or consultants, the authors of, or contributors to, the building information model, and each of their agents and employees.

We are pleased to confirm our understanding of the services we are to provide for the City of Moore, Oklahoma for the year ended June 30, 2025.

#### **Audit Scope and Objectives**

We will audit the financial statements of the governmental activities, the business-type activities, the aggregate discretely presented component units, each major fund, and the aggregate remaining fund information, including the disclosures, which collectively comprise the basic financial statements, of the City of Moore as of and for the year ended June 30, 2025. Accounting standards generally accepted in the United States of America (GAAP) provide for certain required supplementary information (RSI), such as management's discussion and analysis (MD&A), to supplement City of Moore's basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. As part of our engagement, we will apply certain limited procedures to City of Moore's RSI in accordance with auditing standards generally accepted in the United States of America (GAAS). These limited procedures will consist of inquiries of management regarding the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We will not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient appropriate evidence to express an opinion or provide any assurance. The following RSI is required by GAAP and will be subjected to certain limited procedures, but will not be audited:

- 1. Management's discussion and analysis
- 2. Budgetary comparison schedule for the General Fund and any major special revenue funds
- 3. OPEB actuarial valuation funding schedules
- 4. Schedule of City's share of net pension liability
- 5. Schedule of City's retirement contributions

We have also been engaged to report on supplementary information other than RSI that accompanies City of Moore's financial statements. We will subject the following supplementary information to the auditing procedures applied in our audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying

accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS, and we will provide an opinion on it in relation to the financial statements as a whole in a separate written report accompanying our auditor's report on the financial statements.

- 1. Combining and individual non-major fund financial statements
- 2. Debt service coverage schedule
- 3. Schedule of expenditures of federal awards
- 4. Schedule of expenditures of state awards

In connection with our audit of the basic financial statements, we will read the following other information and consider whether a material inconsistency exists between the other information and the basic financial statements, or the other information otherwise appears to be materially misstated. If, based on the work performed, we conclude that an uncorrected material misstatement of the other information exists, we are required to describe it in our report.

- 1. Statistical data
- 2. Oklahoma State Report SA&I 2643
- 3. Sinking Fund Estimate of Needs

The objectives of our audit are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and issue an auditor's report that includes our opinions about whether your financial statements are fairly presented, in all material respects, in conformity with GAAP, and report on the fairness of the supplementary information referred to in the second paragraph when considered in relation to the financial statements as a whole. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS and Government Auditing Standards will always detect a material misstatement when it exists. Misstatements, including omissions, can arise from fraud or error and are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment of a reasonable user made based on the financial statements. The objectives also include reporting on:

- Internal control over financial reporting and compliance with provisions of laws, regulations, contracts, and award agreements, noncompliance with which could have a material effect on the financial statements in accordance with *Government Auditing Standards*.
- Internal control over compliance related to major programs and an opinion (or disclaimer of opinion) on compliance with federal statutes, regulations, and the terms and conditions of federal awards that could have a direct and material effect on each major program in accordance with the Single Audit Act Amendments of 1996 and Title 2 U.S. Code of Federal Regulations (CFR) Part 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards (Uniform Guidance).

#### Auditor's Responsibilities for the Audit of the Financial Statements and Single Audit

We will conduct our audit in accordance with GAAS; the standards for financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States; the Single Audit Act Amendments of 1996; and the provisions of the Uniform Guidance, and will include tests of accounting records, a determination of major program(s) in accordance with Uniform Guidance, and other procedures we consider necessary to enable us to express such opinions. As part of an audit in accordance with GAAS and *Government Auditing Standards*, we exercise professional judgment and maintain professional skepticism throughout the audit.

We will evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management. We will also evaluate the overall presentation of the financial statements, including the disclosures, and determine whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation. We will

plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement, whether from (1) errors, (2) fraudulent financial reporting, (3) misappropriation of assets, or (4) violations of laws or governmental regulations that are attributable to the government or to acts by management or employees acting on behalf of the government. Because the determination of waste and abuse is subjective, *Government Auditing Standards* do not expect auditors to perform specific procedures to detect waste or abuse in financial audits nor do they expect auditors to provide reasonable assurance of detecting waste or abuse.

Because of the inherent limitations of an audit, combined with the inherent limitations of internal control, and because we will not perform a detailed examination of all transactions, there is an unavoidable risk that some material misstatements or noncompliance may not be detected by us, even though the audit is properly planned and performed in accordance with GAAS and *Government Auditing Standards*. In addition, an audit is not designed to detect immaterial misstatements or violations of laws or governmental regulations that do not have a direct and material effect on the financial statements or on major programs. However, we will inform the appropriate level of management of any material errors, any fraudulent financial reporting, or misappropriation of assets that come to our attention. We will also inform the appropriate level of management of any violations of laws or governmental regulations that come to our attention, unless clearly inconsequential. We will include such matters in the reports required for a Single Audit. Our responsibility as auditors is limited to the period covered by our audit and does not extend to any later periods for which we are not engaged as auditors.

We will also conclude, based on the audit evidence obtained, whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the government's ability to continue as a going concern for a reasonable period of time.

Our procedures will include tests of documentary evidence supporting the transactions recorded in the accounts, tests of the physical existence of inventories, and direct confirmation of receivables and certain assets and liabilities by correspondence with selected individuals, funding sources, creditors, and financial institutions. We will also request written representations from your attorneys as part of the engagement.

We have identified the following significant risks of material misstatement as part of our audit planning:

- 1. Management override of controls
- 2. Improper revenue recognition

We may, from time to time and depending on the circumstances, use third-party service providers in serving your account. We may share confidential information about you with these service providers but remain committed to maintaining the confidentiality and security of your information. Accordingly, we maintain internal policies, procedures, and safeguards to protect the confidentiality of your personal information. In addition, we will secure confidentiality agreements with all service providers to maintain the confidentiality of your information and we will take reasonable precautions to determine that they have appropriate procedures in place to prevent the unauthorized release of your confidential information to others. In the event that we are unable to secure an appropriate confidentiality agreement, you will be asked to provide your consent prior to the sharing of your confidential information with the third-party service provider. Furthermore, we will remain responsible for the work provided by any such third-party service providers.

Our audit of financial statements does not relieve you of your responsibilities.

#### Audit Procedures-Internal Control

We will obtain an understanding of the government and its environment, including the system of internal control, sufficient to identify and assess the risks of material misstatement of the financial statements, whether due to error or fraud, and to design and perform audit procedures responsive to those risks and obtain evidence that is sufficient and appropriate to provide a basis for our

opinions. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentation, or the override of internal control. Tests of controls may be performed to test the effectiveness of certain controls that we consider relevant to preventing and detecting errors and fraud that are material to the financial statements and to preventing and detecting misstatements resulting from illegal acts and other noncompliance matters that have a direct and material effect on the financial statements. Our tests, if performed, will be less in scope than would be necessary to render an opinion on internal control and, accordingly, no opinion will be expressed in our report on internal control issued pursuant to *Government Auditing Standards*.

As required by the Uniform Guidance, we will perform tests of controls over compliance to evaluate the effectiveness of the design and operation of controls that we consider relevant to preventing or detecting material noncompliance with compliance requirements applicable to each major federal award program. However, our tests will be less in scope than would be necessary to render an opinion on those controls and, accordingly, no opinion will be expressed in our report on internal control issued pursuant to the Uniform Guidance.

An audit is not designed to provide assurance on internal control or to identify significant deficiencies or material weaknesses. Accordingly, we will express no such opinion. However, during the audit, we will communicate to management and those charged with governance internal control related matters that are required to be communicated under AICPA professional standards, *Government Auditing Standards*, and the Uniform Guidance.

#### Audit Procedures-Compliance

As part of obtaining reasonable assurance about whether the financial statements are free of material misstatement, we will perform tests of the City of Moore's compliance with provisions of applicable laws, regulations, contracts, and agreements, including grant agreements. However, the objective of those procedures will not be to provide an opinion on overall compliance, and we will not express such an opinion in our report on compliance issued pursuant to *Government Auditing Standards*.

The Uniform Guidance requires that we also plan and perform the audit to obtain reasonable assurance about whether the auditee has complied with federal statutes, regulations, and the terms and conditions of federal awards applicable to major programs. Our procedures will consist of tests of transactions and other applicable procedures described in the *OMB Compliance Supplement* for the types of compliance requirements that could have a direct and material effect on each of City of Moore's major programs. For federal programs that are included in the Compliance Supplement, our compliance and internal control procedures will relate to the compliance requirements that the Compliance Supplement identifies as being subject to audit. The purpose of these procedures will be to express an opinion on City of Moore's compliance with requirements applicable to each of its major programs in our report on compliance issued pursuant to the Uniform Guidance.

#### **Other Services**

We will also assist in preparing the annual Sinking Fund Estimate of Needs of the City of Moore in conformity with U.S. generally accepted accounting principles based on information provided by you. These nonaudit services do not constitute an audit under *Government Auditing Standards* and such services will not be conducted in accordance with *Government Auditing Standards*. We will perform the services in accordance with applicable professional standards. The other services are limited to the sinking fund estimate of needs, schedule of expenditures of federal awards, and related notes. We, in our sole professional judgment, reserve the right to refuse to perform any procedure or take any action that could be construed as assuming management responsibilities.

You agree to assume all management responsibilities for the sinking fund estimate of needs, schedule of expenditures of federal awards, and related notes, and any other nonaudit services we provide. You will be required to acknowledge in the management representation letter our assistance with preparation of the sinking fund estimate of needs, the schedule of expenditures of federal awards, and related notes and that you have reviewed and approved the sinking fund estimate of needs, the

schedule of expenditures of federal awards, and related notes prior to their issuance and have accepted responsibility for them. Further, you agree to oversee the nonaudit services by designating an individual, preferably from senior management, with suitable skill, knowledge, or experience; evaluate the adequacy and results of those services; and accept responsibility for them.

#### Responsibilities of Management for the Financial Statements and Single Audit

Our audit will be conducted on the basis that you acknowledge and understand your responsibility for (1) designing, implementing, establishing, and maintaining effective internal controls relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error, including internal controls over federal awards, and for evaluating and monitoring ongoing activities to help ensure that appropriate goals and objectives are met; (2) following laws and regulations; (3) ensuring that there is reasonable assurance that government programs are administered in compliance with compliance requirements; and (4) ensuring that management and financial information is reliable and properly reported. Management is also responsible for implementing systems designed to achieve compliance with applicable laws, regulations, contracts, and grant agreements. You also agree to [include the audited financial statements with any presentation of the supplementary information that includes our report thereon OR make the audited financial statements readily available to users of the supplementary information no later than the date the supplementary information is issued with our report thereon]. Your responsibilities include acknowledging to us in the written representation letter that (1) you are responsible for presentation of the supplementary information in accordance with GAAP; (2) you believe the supplementary information, including its form and content, is fairly presented in accordance with GAAP; (3) the methods of measurement or presentation have not changed from those used in the prior period (or, if they have changed, the reasons for such changes); and (4) you have disclosed to us any significant assumptions or interpretations underlying the measurement or presentation of the supplementary information.

Management is responsible for establishing and maintaining a process for tracking the status of audit findings and recommendations. Management is also responsible for identifying and providing report copies of previous financial audits, attestation engagements, performance audits, or other studies related to the objectives discussed in the Audit Scope and Objectives section of this letter. This responsibility includes relaying to us corrective actions taken to address significant findings and recommendations resulting from those audits, attestation engagements, performance audits, or studies. You are also responsible for providing management's views on our current findings, conclusions, and recommendations, as well as your planned corrective actions for the report, and for the timing and format for providing that information.

However, subject to applicable laws and regulations, audit documentation and appropriate individuals will be made available upon request and in a timely manner to a Cognizant or Oversight Agency for audit or its designee, a federal agency providing direct or indirect funding, or the U.S. Government Accountability Office for purposes of a quality review of the audit, to resolve audit findings, or to carry out oversight responsibilities. We will notify you of any such request. If requested, access to such audit documentation will be provided under the supervision of Dillon & Associates, PC personnel. If our opinions are other than unmodified, we will discuss the reasons with you in advance. If, for any reason, we are unable to complete the audit or are unable to form or have not formed opinions, we may decline to express opinions or issue reports, or we may withdraw from this engagement.

The Government Auditing Standards report on internal control over financial reporting and on compliance and other matters will state that (1) the purpose of the report is solely to describe the scope of testing of internal control and compliance and the results of that testing, and not to provide an opinion on the effectiveness of the entity's internal control or on compliance, and (2) the report is an integral part of an audit performed in accordance with Government Auditing Standards in considering the entity's internal control and compliance. The Uniform Guidance report on internal control over compliance will state that the purpose of the report on internal control over compliance is solely to describe the scope of testing of internal control over compliance and the results of that testing based on the requirements of the Uniform Guidance. Both reports will state that the report is not suitable for any other purpose.

We are independent within the meaning of the AICPA Code of Professional Conduct.
